Subject:	Traffic Regulation Order for Howards Lane Car Park
Prepared by:	Deputy Town Clerk
Purpose of Report:	To approve the drafting of a new Traffic Regulation Order (TRO) for Howards Lane Car Park.
Background:	Electric Vehicle (EV) Charging Points were installed in Howards Lane car park in 2023.
	When attempts were made to add the new EV parking bays to the TRO with Dorset Council for traffic enforcement, it became apparent that the TRO had been expired in Howards Lane car park for several years.
	TROs are legal documents that support measures to restrict or regulate the use of roads by vehicles or pedestrians and to enable the enforcement of parking restrictions.
	Enquiries were made with the Service Manager for Parking Services, Economic Growth and Infrastructure, Dorset Council, and it became evident that a new TRO would have to be drafted to cover the inclusion of the new EV charging Point spaces.
Key Points:	The cost of a new TRO is £3,000, which is a specialist, legal process undertaken by Highways Department, Dorset Council, and negates alternative quotes.
	Without a current and correct TRO parking restrictions cannot be enforced, which could lead to a loss of revenue for the Council.
Implications	Financial – There is no specific budget for a new TRO to be drafted, however the <i>Professional Fees – Legal Costs and Fees</i> has £2,005 remaining which could be earmarked into the next financial year, with the remaining £1000 taken from the same budget line in 2024/25 which has £2,500 allocated.
	Financial - Risk of financial loss if users of Howards Lane do not pay parking fees if they believe that restrictions are not being enforced.
Recommendation	To approve the drafting of a new Traffic Regulation Order for Howards Lane car park by Dorset Council and agree the respective budget for covering the cost.
