

Minutes of a meeting of the Town Council held on 11 November 2025 in the Council Chamber, Town Hall, East Street, Wareham at 7.30pm.

TC 119/25-26 Apologies for absence

Apologies were received and accepted from Cllr M Tighe, Cllr R Holloway and Cllr S Wheatley.

TC 120/25-26 Declarations of interest

There were no declarations of interest.

TC 121/25-26 Public participation time

There were three members of the public present, one of whom wished to speak in relation to the Community Speed Watch Team. The group is in need of more volunteers and locations suggestions, to be able to carry out speed surveys for Dorset Police. A second resident requested an update on the proposed new facilities at Hauses Field.

TC 122/25-26 Confirmation of the minutes of the previous meeting

It was **RESOLVED** the minutes of the meeting of the Town Council held on 28 October 2025 be **APPROVED** and were signed by the Mayor.

TC 123/25-26 Matters arising from the minutes of the previous meeting

Cllr Budd enquired whether the documents verbally requested by a member of public at the previous meeting's public participation section had been sent and whether there was a procedure in place for how Council responds to residents who address Council under public participation. The Deputy Clerk noted that the requested documentation, if held, would be sent to the resident requesting it, but that any request for documentation from the Council such as this should be made in writing to the Council.

Cllr Critchley noted his concern at the progress of the asset transfer for the former Middle School Playing field and that there appeared to be a disconnect between the approach towards the transfer of assets of officers within Dorset Council and elected members of Dorset Council respectively. Cllr Critchley proposed that the Town Council write to Cllr Richard Biggs, Deputy Leader and Portfolio Holder for Property & Assets, Economic Growth & Levelling Up, to reaffirm the Town Council's position in relation to the asset transfer of former Middle School Playing field.

TC 130/25-26 Ride on Mower Expenditure Approval

Councillors considered the recommendation from the Policy, Resources and Finance Committee for the purchase of a ride on mower.

Cllr Dallimore enquired whether the purchase of any additional scarification had been considered to preserve the long-term health of the pitch. The Deputy Town Clerk noted that equipment such as this could be purchased and mounted to the mower at a future point in time if Council wished for it and further highlighted that a flail cutting deck would also be mountable to the mower at a future point which could also scarify playing fields.

It was **RESOLVED** that to purchase an FD 13.09 Stage5 4WD (Grillo) machine with 61-inch rotary cutting deck at £27,750 excluding VAT from Hunt Forrest, with the expenditure being taken from the "Ride on Mower" earmarked reserve.
