83. Traffic issues in the town

Councillor R Schofield raised a number of concerns regarding parking in the town of Wareham.

The main points were

- Publicity an opportunity to reinforce the safety message and to publicise the problems that are being encountered around the town that could lead to another fatality.
- Proposed day of action a publicised day of enforcement of traffic/parking violations

 Policing day – an unpublicised day of action to enforce traffic/parking violations.

It was felt that the problem areas in town were North Street, South Street, Lloyds cashpoint, CO-OP, disabled parking on North Street, West Street, St Johns Hill area and areas in close proximity to take away restaurants and pedestrian crossings.

The question was raised as to whether Dorset Council would supply further traffic wardens to police the problems that the town is experiencing.

The issue surrounding the difficulties that wheelchair users and low mobility members of the public who have trouble mounting and dismounting pavements around the town was also raised. It was suggested that a survey should be done of the town to ascertain the location and number of dropped kerbs in the town and perhaps approach Dorset Council if it was proved that more dropped kerbs were required.

Resolved that the Operations Manager would approach Dorset Council to enquire what could be done with regards to enforcement, publicity and the dropped kerbs.
